**OBJECTIVE:** Total return (capital appreciation plus income)

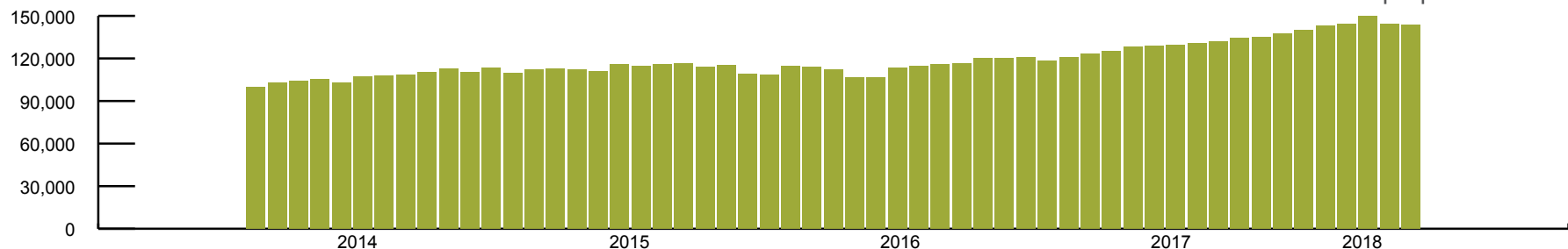

**SUITABILITY:** This portfolio is utilized by investors with a long-term investment horizon who seek a relatively high exposure to equity markets.

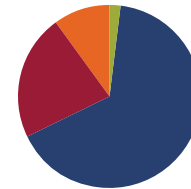
