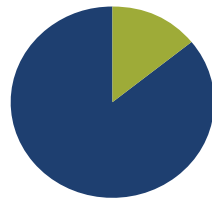

Benchmark Description:

The **Morningstar US Active Fund Tactical Category** is a composite of global risk-managed strategies and represents a "best-fit" benchmark for the portfolio.
